Personal data that we process

The following table explains the types of data we collect and the legal basis, under current data protection legislation, on which this data is processed.

Subscribing to email updates about our work	Name, email	Consent - you have given your active consent.
Signing up as an associate or full member	Name and title Contact information including address, telephone numbers and email address Emergency contact details Details of your RoSPA membership and test results	Contract - by paying your membership fees you enter into a contractual relationship with us.
Website functionality	Website activity collected through cookies	We do not use cookies to collect personal data. For more information, see "Cookies & usage tracking" below.

How we use your data

We will only use your data in a manner that is appropriate considering the basis on which that data was collected, as set out in the table at the top of this policy.

For example, we may use your personal information for:

- Replying to enquiries you send to us
- Handling payments or other transactions that you initiate
- Internal record keeping
- Contacting your family in case of emergency
- Reminding you of your next RoSPA test
- Letting you know of upcoming Suffolk Riders events by email or telephone. We consider this to be an essential part of our operation and as such does not constitute "Direct Marketing"

When we share your data

We will only pass your data to third parties in the following circumstances:

- you have provided your explicit consent for us to pass data to a named third party
- we use a third party for the purposes of processing data on our behalf and we have in place a data
 processing agreement with that third party that fulfils our legal obligations in relation to the use of
 third party data processors
- we are required by law to share your data

In addition, we will only pass data to third parties outside of the EU where appropriate safeguards are in place as defined by Article 46 of the General Data Protection Regulation.

How long we keep your data

We take the principles of data minimisation and removal seriously and have policies to ensure that we only ever ask for the minimum amount of data for the associated purpose and delete that data promptly once it is no longer required.

Rights you have over your data

You have a range of rights over your data, which include the following:

- Where data processing is based on consent, you may revoke this consent at any time and
 we will make it as easy as possible for you to do this (for example by putting 'unsubscribe' links at
 the bottom of all our marketing emails).
- You have the right to ask for rectification and/or deletion of your information.
- You have the right of access to your information.
- You have the right to lodge a complaint with the Information Commissioner if you feel your rights have been infringed.

Cookies & usage tracking

A cookie is a small file of letters and numbers that is downloaded on to your computer when you visit a website. Cookies are used by many websites and can do a number of things, such as remembering your preferences, recording what you have put in your shopping basket, and counting the number of people looking at a website.

We do not use cookies to collect personal data. However, we use some cookies to help us collect anonymous information about how people use our website. We use Google Analytics for this purpose. Google Analytics generates statistical and other information about website usage by means of cookies, which are stored on users' computers. The information collected by Google Analytics about usage of our website is not personally identifiable.
